

**SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

**ELIGIBILITY:** Only legal residents of the State of CA, 18 years of age or older, may enter. Not open to employees, officers or directors -- or to members of the immediate family or household of any of the foregoing -- of Sprouts Farmers Market, Inc. ("Sponsor") or any of their respective parents, subsidiaries, affiliates, or any advertising or promotion agencies involved in this Sweepstakes promotion (collectively, the "Sweepstakes Entities"). **VOID OUTSIDE CA AND WHERE PROHIBITED.**

**SWEEPSTAKES PERIOD:** The Sweepstakes (the "Sweepstakes") begins on Monday, September 2, 2024, at 12:00:01 am local time and ends Sunday October 13, 2024, at 11:59:59pm local time (the "Sweepstakes Period"). The Sponsor's database computer is the official time-keeping device for this Sweepstakes. Proof of submission is not proof of receipt.

You may also be given the option to receive promotional weekly specials and monthly newsletters from the Sponsor, however, your election to do so is optional and will not affect your chances of winning. Entry is available once in the Sweepstakes Period. By participating in the Sweepstakes, you unconditionally accept and agree to comply and abide by these Official Rules and all decisions of the Sponsor, which shall be final and binding in all respects. All entries must be received by the end of Sweepstakes Period.
